

- (A) the exclusive purpose for which the student data, teracher principal data will be used;
- (B) how the third party contractor will ensutheat the subcontractors, persomsentities that thethird party contractorwill sharethe student data or teacher principal data with, if any, will abide bydata protectionand security requirements;
- (C) when the agreement with the third party contractor expires and what happens to the student data or teacher or principal data upon expiration of the ement;
- (D) if and how a parent, studentigible student, teachen principalmay challenge the accuracy of the student datar teachen principal data that collected; and
- (E) where the stude notataor teacher principal datawill be stored (described n such a manner as to protect data security), at the security protection staken to ensure such data will be protected, including wheth such datawill be encrypted.

Model Notification of Rights under FERPA for Elementary and Secondary Schools

The FamilyEducational Rights and Privacyct (FERPA) affords parents and students who are 18 years of age or olde ("eligible students") certain rights with specto the student sudent records. These rights e:

interestif the official needs to review an education recordider to fulfill his or her professional responsibility.

[Optional] Upon request, the school disclosed scation records it hout consent o officials of another school disct in which a student seeks or intends o enroll, or is already enrolled if the disclosures for purposes of the student's enrollment mansfer. [NOTE: FERPA requires a school district o make a reasonable attempt notify the parent or student of the ecords request unless it states in its annual notification that it intends to forward records on request.]
