Such projects include improving indoorair quality, increasing access to the outdoors, facilitating cleaning and sanitization efforts, and acilitating physical distancing. Specific examples highlighted by ED include:

- x Servicing or upgrading HVAC systems consistent apptilicable federal, state, and local standards industry standards
- x Repairing windows and/or doors so they can open to let fresh air in
- x Installing or upgrading indoor air quality tools like filter, purification, fan, and control systems,
- x Roof repairsor replacement to improve indoor air quality (for example, to address leaks that lead to mold and diminished air quality)
- x Mold, radon, and asbestos remediatiôn,
- x Creating outdoor spaces learning and other activities like eating lunch
- x Replacing carpet with easied-clean flooring,
- x Renovations to facilitate physical distancing d
