The Standards leverage four Art st c Processes—Creat ng, Performing, Responding, and Connect ng—to support students' art st c literacy.

- Mult ple modes of learning and expression.

• Creat ng, Performing, Responding, and Connect ng experiences.

• Build a more integrated understanding of self and community.

• Directly engage students in independent and collaborat ve goal-seeking choices.

• Inspire, engage, challenge, and focus the mind.

• Build collaborat on and problem-solving skills.

• Lay a foundat on for creat ve capacity, and the development of innovators and creators.

21st Century Skills include creat vity, crit cal thinking, collaborat on, and communicat on.

Part cipat on in the Arts facilitates creat ve problem solving and innovat ve thinking, which encourages global learning and civic engagement. Arts students focus on ideas, interact ons and collaborat on. They part cipate as decision-makers in the product on, presentat on, or performance of their art st c work.

Counselors, teachers, and students should work together in partnership with professional artists to expand curriculum-based Arts experiences and create opportunit es for work experience.



## ARTS STANDARDS

Four *Art st c Processes* (Creat ng, Performing/Present ng/Producing, Responding, and Connect ng) and eleven *Anchor Standards* are shared by all arts disciplines. These represent the essent al undersandings and skills students gain

as they engage in the arts.

*Enduring Understandings* and *Essent al Quest ons* provide discipline specific guidance toward acievement of the Anchor Standards. Grade level specific *Performance Indicators* ident fy key outcomes by grade level within the specific Arts disciplines.
